HYPOTHESIS OF LIFE home

EXPLANATION OF THE WEAK GRAVITY CONDITION for the hypothesis In 2024 better explained than previously

The definition of the weak gravity condition is the macroscopic entanglement between the radial and the angular momentum for a sphere of macro mass by the ultra fast and ultra light mediating medium of dark matter. The macroscopic entanglement for gravity is in many aspects equivalent to quantum mechanics of the atoms based on Einstein's special relativity theory combined with Heisenberg's uncertainty condition.

The generation of gravity is controlled by the event horizon expressed in dissipation free electromagnetic energy. All atoms in the macro mass synchronise in a somewhat complex manner to the event state, even if the size of the macro mass exceeds many, many times the event state. Without the existence of the mediating medium of ultra fast and light dark matter to put the atoms into coherence, gravity generation is impossible. It is this medium that separates the atoms in alternating groups, the macro entanglement. In a coarse manner one group has the task of radial inward acceleration while another group converts the radial impulse into rotation energy internally giving the three dimensional sphere spin which is counterbalanced by the inertia rotation of the atoms not contributing to the fast exchange. As a reaction to the inward drive impulses of the light medium, the medium escapes outwardly. Due to the electron alignment of the atoms in coherence, a momentary magnetic state is reached which determines that the medium behaves as a rigid rotor for that group of atoms then converting its energy to another momentary rigid rotor of the other coherent group and so on in repetitive cycle without actual changing the position of the atoms which are only slowly adapting to the fast exchange.

If the exchange between the rigid rotors of the fast medium is always with the same frequency then no transfer of the radial impulses to angular momentum takes place. So the coherent groups (rotors) operate at different frequencies determined by Sacharov's law of induction for the fast dark matter medium. In fact for a solid macro mass with no change of its outward diameter, the angular momentum of the fast medium is in rotation equilibrium to the inertia rotation of the macro mass.

The above simplified description of the weak gravity condition is valid anywhere in our cosmos and valid for stars, planets, moons and comets. Even the super massive black holes comply with the weak gravity condition. gravity site

Inconsideration of intelligent life in our cosmos, the weak gravity condition is a necessary condition for collective mind merging of an intelligent race, guessed energy about 5 watt mind power per kilogram matter. The cycle of intelligent race is as follows:

- 1. On a life carrying planet, evolution of biologic life, flora, fauna culminates into an intelligent race. Consciousness awakening, sometimes externally seeding by other completed races to the new evolving race.
- 2. The formation of a small hollow black hole, planet size of the life carrying star by the unification of individual minds for the separation between dominant and altruistic intelligence. The formation of the Holy Spirit of mankind prevents eternal suffering. Departure of the race to the Heavens of the super massive hollow black holes. The planet-sized black hole roaming through space by predetermined path preventing collision accidents for a couple of million years.

THEORY OF LIFE overview

The theory of life adheres to the hypothesis that cellular life is controlled by the overall exchange to the ultra fast and ultra light mediating medium of dark matter. Also the hypothesis tries to make plausible the separation of the mind, the emotional experience based on electromagnetic impulses as the immaterial state against the inertia state of the atoms carried by the dark matter symmetries. In fact

once one understands the process of gravity generation by the weak condition, the idea of the separation between dead and living matter can be explained.

Biologic life is energy consuming, because the ultra fast medium needs to be maintained by the coherent alternating process of the medium to the inertia of the atoms. This process seems to be principally controlled by the anomalous magnetic moment of the H atom, momentary alignment of magnetism of the fast medium. This atom in all its different attachments to other atoms is the dominant state for the coherent alternation and is decoupled from the other magnetic biochemical processes, similar to gravity where the inertia of the atoms does not affect the fast dark matter exchange of the medium. The healthy state of a cellular conglomerate attuned to the DNA state, generates the slow frequencies of alternation by non dissipative electromagnetic frequencies and these are difficult to observe. In fact the immaterial state of a living being can be associated to the soul, contained in the ultra light dark matter medium, which develops during life in a memory state, information written away as a guess in binary gravitation coherence of the life (as virtual photon energy to time) carrying star planet system. In terms of the fast mediating ark matter medium the soul is during life the alternating electromagnetic process monitoring the overall cellular state of the biologic entity. All kinds of cellular life distinguish flora, plants, fauna, animals as collective 'souls' while humans develop individual souls.

CLASSIFICATION OF THE HYPOTHESIS OF LIFE

The potential of the fast qubit network driven by external energy either directly by Sun, flora, or indirectly by bio-energy, fauna is based on the dynamics of the hyperfine structure of the Hydrogen atom.

Definition of the fast qubit network.

Real time energy against virtual energy of time modulation in 3D space determined by R_{bio} product rule according to theory of dynamic gravity generation. All conform to the understanding of gravity generation by the dark matter medium or mediating mass of the H atom. Resulting in bio coherence luminescence or electromagnetic radiation. The dynamics, only observed, results in very weak intensity of healthy single cell bio systems, the order of the micron or more spectrum but not heat radiation.

Explanation of the fast qubit network

In short to get some impression, a fast qubit network surrounds living cells of which the anomalous magnetic moment of the proton drives the alternating conjugation with the <u>electron</u>. It is a reflection of the hyperfine structure spectrum of the H atom. No other atoms have an anomalous magnetic moment as the H atom. All **H atoms** of say N number of atoms in the biomass of a species are subjected to the product rule determined by dividing <u>H atoms</u> into two states of about \sqrt{N} atoms needed for the fast alternation conjugation of the dark matter mediating medium. In simplified terms, the angular momentum of these states couples to the other atoms in the DNA of the genes via R_{bio} then determining the <u>extraction</u> code following the chemical exchange condition laid down by the inertia of these atoms.

For species flora or fauna the maximum potential is 2⁴⁰ qubits <u>Qubit definition</u> each or 1.1 10¹² qubits or binary options giving the diversity of life in species or human consciousness. Both are available on a life-carrying planet. As an example, one sole living cell, bacteria, is driven by as a guess a Q network of a million sequential binary steps. A billion seems too much, not all chemical interactions are binary driven.

The template of the fast qubit network, like quantum computers, drives all the kinds of atoms necessary for biological life. This is the condition of the bio intelligence code, extraction code or binary algorithm, the conversion in time sequences. Template definition by the R_{bio} which is the energy ratio, like the gravity energy ratio between living and inert life, the 'dead' or zero state of an

organic system but still complete. R_{bio} is always greater than one. For multiplication, growing, R_{bio} can be great and for hibernation (winters), cold blooded(reptiles, insects, plants, not active then minimal.

There are possibly three categories of bio intelligence coding to be distinguished:

- 1. DNA template, the size of Q network, similar to DNA following the rule of the least nominator in diversification, such as skeleton, organs, sensor systems.
- 2. The instinct of survival coding using Boolean logic for the potential of the use of one or all the five senses as seen, hearing, feeling, taste and smell to survive and grouped as 'body language'. Applicable to individuals (predators, herbivores), groups (lions or herds), or collective intelligence termites, bees, ants. Collective intelligence coding is new but communication is by the senses. Dominant leadership, negative charisma, using people for their own purposes. Group wars as protection. As well in animals as in the human domain. Floral life has the template and the survival coding. Beautiful examples are the films of symbioses of flora and fauna in the Okavango river/delta(Africa) and Panatelas (South America).
- 3. Coding of altruistic care, the immaterial coding. Hormone driven, procreation, and/or seasonable cycle, taking care of offspring. Well being of individuals or groups. Social leadership (positive charisma) inspiring but not dominant, Bono society, harmony. Fish swarming, self hypnosis within the group, against losing life. Swarming birds sunset or dawn, group enjoyment. The altruistic coding comprises 2⁴⁰ qubits in diversity incarnated in the race.

Some layman's explanation may help in point 3:

It means hardware, driving the eye movements of the closest neighbour to overall synchronisation. It triggers individual brain 'happiness' feeding the immaterial well being of the species collectively. Collective intelligence in ant survival by tracing bio scent molecules of an individual ant, is the opposite idea. Here the immaterial coding of the species organises the stochastic hardware of scent molecules in survival of the collective.

Humanity, the intelligent races

The evolution goal of the fast Qubit network for an intelligent race in planetary condition is the final state of overall altruistic care for 99.999% of all persons having lived.

Guessed prediction, in the end only a small group will reject altruistic coding which is about sq root of qubit fast network, 2^{20} or one to two million persons. At the end the whole race attunes itself to a qubit state of 2^{40} qubits. (Mind merging)

Distinction:

- 1. Races with no planetary catastrophes, rotation axis in equatorial plane of plane. Working mind 16 to 32 qubits on average for a person, language driven, Boolean coding in persons only but also collective intelligence (meditation?) 64 qubits during the evolution of the race.
- 2. Races with a tilt of rotation axis to the equatorial plane subjected to solar shifts. Grand deluges, axis reversal.

Final stage of evolution of the race can be characterised by the potential of imminent solar shift, which can be enhanced by reversal of the magnetic field dipole in the planet.
